## OFFICE MEMORANDUM

Subject: Modified Instructions regarding Conduct of All India Trade Test (AITT) for Craft Instructor Training Scheme (CITS) for the Academic Session -2018-19, 2019-20 and 2020-21.

Consequent upon receipt of representations from a very large of number of registered candidates for AITT with regard to relaxation in attendance requirement as prescribed due to Covid-19 situations, the matter has been reconsidered for relaxation taking into account various restrictions imposed due to Covid19 pandemic as one time measure and the following decisions have been taken in respect of **only those candidates who have already been registered on NIMI Portal as per detail given below:-**

- (i) Regular Candidates of 2020-21 Batch and 2019-20 Batch Who could not write their examination due to Covid-19:- All registered candidates on NIMI Portal who have got at least 30 days or more of Physical Attendance corresponding to 40% of the physical classes would be eligible to sit for AITT Examination now scheduled to be held on 29-11-2021 to 01-12-2021 followed by practical examination. However, those candidates who have already got their hall tickets from NIMI Portal and who are otherwise eligible without any relaxation in attendance as per previously prescribed criteria would appear at the examination scheduled to commence from 22-11-2021 onwards.
- (ii) Further, those candidates who have not got the Hall Tickets from NIMI Portal including those whose Hall tickets are defective as well as those candidates who have become now eligible due to relaxation in attendance criteria given above, shall appear at the examination commencing from 29-11-2021 to 1-12-2021 followed by practical exam.
- (iii) Candidates for supplementary examination for 2019-20 and 2018-19 Batches: Condition of Minimum Attendance is waived for candidates for supplementary examination now scheduled to be held from 29-11-2021 to 1-12-2021 followed by practical examination.
- (iv) Where proper Hall Tickets could not be generated through NIMI Portal and where Hall Tickets are defective, the RDSDEs / Principals of NSTIs /NSTI (W) / ITOTs are authorized to issue Hall Ticket through a Manual Process by observing due diligence to those registered candidates who have become eligible as per instructions contained in the preceding paragraphs.
- (v) Respective NSTI/IToT shall be self-center for "Theoretical and Practical subjects" for AITT in respect of registered students under their jurisdiction. Further, the Principals of all NSTIs/NSTI (W)/ITOT shall ensure remedial classes for those students who have less than 30 days of physical attendance so that they become eligible for subsequent supplementary examination to be held after publication of result of the current batch of 2020-21.
